Theoretical education and training

- The Bare Essentials (Module 1 of the Certificate in Sexual and Reproductive Health. A 2 day face to face workshop) Available for all nurses inclusive of enrolled nurses and school health nurses.
- STI Clinical Management (Module 3 of the Certificate in Sexual and Reproductive Health) online learning and a 1 day practical workshop
- Cervical Screening Theory Module 2 of the Certificate in Sexual and Reproductive Health. A 3.5 day face to face workshop
- Contraception and Communication (Module 6 and 7 of the Certificate in Sexual and Reproductive Health). A 1 day face to face workshop

For Nurses to achieve a Certificate in Sexual and Reproductive Health they need to compliment education with clinical practice.

SHQ staff can supervise nurses after completion of theory in their own workplaces to assist them to achieve clinical competency in

- Cervical Screening
- Contraception
- STI clinical management

A combination of both education and clinical practice is available and is dependent on:

- Time available
- Access to patients for clinical practice purposes. (the patients will need to be sourced by the nurse in the nurses workplace)
