

FPAACertificate in Reproductive and Sexual Health for Doctors



This national certificate course covers sexual and reproductive health issues at a postgraduate level.

The course is an RACGP accredited activity. Accreditation by ACRRM will be applied for when required. The course is held in high esteem and thought to be very practical in nature, giving participants the confidence and skills to work at a high level in this area. The course focuses on primary care aspects of sexual and reproductive health, a core aspect of both general practice and specialist training in obstetrics and gynaecology.

Course Content – five-day theory

- Reproductive physiology
- Contraception: information on different contraceptive options, both hormonal and non-hormonal, and management of problems associated with their use
- Management of unintended pregnancy, including medical, psychosocial, counselling and legal aspects
- Diagnosis and management of sexually transmitted infections
- Cervical and breast screening
- Menopause management
- Management of subfertility
- Gynaecology: menstrual problems, vulval disorders, fertility
- Men's sexual health: office urology, male sexual difficulties

Full Course: Five day theory and seven clinical sessions for doctors who want to obtain the FPAACertificate in Reproductive and Sexual Health.

Participants must complete:

- Pre-course reading and activities (approximately 6 hours)
- A five-day theoretical component, including submission of a take home assessment within one week after completion of the theory.
- A minimum of seven clinical sessions consisting of three and a half hours each. Sessions are to be arranged at times suitable to the applicant and SHQ
- Supervised clinical attachment (SCA) can only be completed by those with the equivalent of 6 months full time general practice or sexual health experience.
- SCA is to be completed after the theory course, ideally within one year. In difficult circumstances, up to two years may be possible. To organise SCA, email the Clinical Education Coordinator, clinic.ed@shq.org.au

Please note: GP Registrars who are selected to do the Extended Skills term at SHQ do not need to enrol for the clinical attachment.

To complete the supervised clinical attachment, participants must have current registration with AHPRA, and SHQ requires that doctors obtain their own medical indemnity insurance.

Theory only: Designed for participants who wish to obtain up to date knowledge in the field of sexual health. This option consists of the five-day theoretical component only. A Certificate of Attendance is issued on completion of the course.

Individual Modules: Doctors may choose to complete individual modules according to their needs or areas of interest. These modules may be credited towards the Certificate in Reproductive and Sexual Health, provided that all theoretical modules are completed within one year from the commencement of the first module.

Venue:

The theory course is held in the Lecture Theatre at SHQ, 70 Roe St (cnr Lake St) Northbridge, Western Australia daily from 8.30am to 5.00pm Monday to Thursday, 8.30am to 3.00pm on Friday.

Supervised clinical attachment is held in the SHQ Clinic, 70 Roe St Northbridge WA.
